## Policy Intention

McKeon Swim School Pty Ltd is committed to providing quality services and your right to privacy and confidentiality will be recognised, respected, and protected in all aspects of your contact with us. This statement outlines our ongoing obligations to you in respect to how we manage your Personal Information.

## What is Personal Information and why do we collect it?

Personal Information is information, data or payment information relevant to an individual or person(s). Examples of Personal Information we collect include for instance:

- Names
- addresses
- email addresses
- phone numbers
- personal Information i.e. Health Information
  - physical
  - mental health
  - disability of an individual.
- Personal financial information

We collect your Personal Information in many ways including:

- interviews
- correspondence
- telephone
- email
- via our website
- other publicly available sources
- third parties.

McKeon Swim School Pty Ltd will only request and retain Personal Information that is necessary to:



- assess your eligibility for a service;
- provide a safe and responsive service;
- monitor the services provided; and
- fulfil contractual requirements to provide non-identifying data and statistical information to a funding body
- to make payment for services provided.

When we collect Personal Information, we will explain to you why we are collecting the information and how we plan to use it.

## Third Parties

Where reasonable and practicable to do so, we will collect your Personal Information only from you. However, in some circumstances we may be provided with information by third parties (such as disability support services). In such cases we will take reasonable steps to ensure that you are made aware of the information provided to us by the third party.

Where required to do so to take ongoing payment for services, financial information will be required. Note that the McKeon's Swim School does not retain any financial information (credit card, bank account details). For all Direct Debit payments by credit card or direct bank transfer, we use a third-party provider (Worldpay for Platforms). ## Disclosure of Personal Information

Your Personal Information will only be disclosed:

- to prevent or lessen a serious and imminent threat to the life or health of you or another person;
- to outside agencies with your or your representative's permission;
- with written consent from a person with lawful authority; or
- when required by law, or to fulfil legislative obligations such as mandatory reporting.

## Security and Destruction of Personal Information

Your Personal and Health Information is stored in a manner that reasonably protects it from misuse and loss and from unauthorized access, modification or disclosure.

When your Personal and Health Information is no longer needed for the purpose for which it was obtained, we will take reasonable steps to destroy or permanently de-identify it.

We will retain and dispose of your Personal and Health Information in accordance with the relevant authorities.

## Access to your Personal Information

You may access the Personal or Health Information we hold about you, including to update or correct it, subject to certain exceptions. If you wish to access your Personal or Health Information, please speak to a staff member.

In order to protect your Personal or Health Information we may require identification from you before releasing the requested information.

You have the right to:

- request access to personal information we hold about you;
- access this information; and
- make corrections if you consider the information is not accurate, complete or up to date.

However, access may be denied in part or in total where:

- the request is frivolous or vexatious;
- providing access would have an unreasonable impact on the privacy of other individuals;
- providing access would be likely to prejudice an investigation of possible unlawful activity;
- providing access would pose a serious and imminent threat to the life or health of any individual; and

- denying access is required or authorised by or under law.

We aim to address all requests to access or correct information within 2 working days. We will not charge any fee for your access request but may charge an administrative fee for providing a copy of your information.

## Maintaining the Quality of your Personal Information

It is an important to us that your information is up to date. We will take all reasonable steps to make sure that your Personal Information is accurate and complete. If you find that the information we have is not up to date or is inaccurate, please advise us as soon as practicable so we can update our records and ensure we can continue to provide quality services to you.

## Policy Updates

McKeon Swim School Pty Ltd will review its record retention policy when there is a change in legislation or every 3 years.
